

Bundy Ranch Trial; BLM Agent Wooten Files Whistleblower Affidavit-Conspiracy to Commit Murder

BLM agent Larry Wooten did his duty as an American and as a paid, government bureaucrat and filed an 18 page whistleblower affidavit on **multiple accounts of gross misconduct including criminal conspiracy to commit murder on the part of BLM agent Dan Love** regarding Cliven Bundy, 2 of his sons and others involved in the Bundy Ranch protest of 2014. **The conspiracy involves others employed in the BLM and the FBI.** The report/affidavit is dated November 27th, 2017 and the trial began November 14, 2017.

Judge Navarro suspended the hearing for more than a week and sent the jury home. In my opinion this is **to give the prosecution time to rewrite their story and prepare for an exit that is as graceful as possible and to prepare for damage control to save what little is left of the integrity and reputation of the BLM, FBI and the Federal Government in general; including the Federal Justice Department and Navarro. Take notice as the two tier justice system will be revealed in this matter as no charges will be filed against Dan Love or any other BLM or FBI employees.**

In the second video Washington State Representative, Matt Shea, points out some of the astounding revelations in Wooten's report. Starting at minute 12:00 he describes what Wooten refers to as Dan Love's personal "Kill Book".

The report also describes what appears to be additional people on the **BLM hit list, this time, however, Wooten's own supervisor was an accessory.**

My supervisor even took photographs in the secure command post area of the Las Vegas FBI Headquarters and even after he was told that no photographs were allowed, he recklessly emailed out photographs of the "Arrest Tracking Wall" in which [Eric Parker](#) and Cliven Bundy had "X's" through their face and body (indicating prejudice and bias)....."
