[Christian Judge suspended for Refusing Gay "Marriage"](#)

"An evangelical judge who has refused to marry same-sex couples was handed down a **three-year suspension without pay** Thursday by the Oregon Supreme Court, the longest suspension in the court's history," [reports](#) Christian Post.

"Judge Vance Day, who was found to have broken several gun laws, and in 2014 refused to marry same-sex couples, will have 14 days to file a petition for the state Supreme Court to reconsider its decision.

"One of the main charges that Day was found guilty of concerned granting a gun to a felon who was on probation while Day served as judge at a special court for veterans.

"The court also ruled that Day had acted with prejudice against same-sex couples after he allegedly instructed staff at his office to say that he was **unavailable for same-sex marriage requests**, while heterosexual couples had their weddings scheduled...



"Our belief is he's being targeted for his Christian beliefs," said Ralph Spooner, one of Day's attorneys, on OPB.org.

"In our society, it's perfectly fine to test these legal principals," he added, "but I think whether you're a Christian, a Muslim — whatever your faith is — that doesn't disqualify you from being a judge."

"While an ethics commission called for Day to be removed from office in 2016, Janet Schroer, another one of his attorneys, said that such a move would go too far.

"The court's suspension overlooks the fact that during the brief time Judge Day discretely declined to perform same-sex marriages, the Oregon Constitution prohibited same-sex marriage by referendum of the people," Schroer explained. "And it wasn't until a year later the U.S. Supreme Court ruled conclusively, determining that the U.S. Constitution prohibits Oregon's ban on same-sex marriages."

[Christian on Supreme Court? Trump picks 5 new potential nominees](#)

In yet another nod to religious freedom, **President Trump selected 5 more conservative judges** to add to his previous list of 20 judges he would consider for elevation to the U.S. Supreme Court.

Of particular note, the pro-life Judge Amy Barrett (a Notre Dame graduate) was recently attacked by anti-faith Democrats because she is a Catholic Christian, and opposes abortion.

"In a move certain to please conservatives, President Donald Trump on Friday added five names to his list of candidates for a prospective U.S. Supreme Court vacancy as he presses ahead with a campaign to move the federal judiciary to the right," [reports Reuters](#).



"Two of them are appellate judges who were nominated by Trump earlier this year and confirmed by the Senate: **Amy Coney Barrett** and Kevin Newsom. Another, Brett Kavanaugh, sits on the U.S. Court of Appeals in Washington, long viewed as a stepping-stone to the high court.

"The others were Britt Grant, a Georgia Supreme Court justice, and Patrick Wyrick, a Oklahoma Supreme Court justice.

"There is no current vacancy on the U.S. Supreme Court but three justices are 79 or older.

"During his presidential campaign last year, Trump identified 20 conservative

candidates for the Supreme Court. Upon taking office, he named Neil Gorsuch to the court to replace the late Justice Antonin Scalia, restoring the Supreme Court's conservative majority. Gorsuch was confirmed by the Senate in April and has established himself as one of the Supreme Court's most conservative justices.


"Speaking at a Federalist Society conference of conservative legal advocates, White House Counsel Donald McGahn said **Trump is 'very committed' to appointing judges who are 'committed originalists and textualists,'** referring to a legal philosophy that relies on the actual wording of laws and the original meaning of the U.S. Constitution."
